- Vendors will provide their own tent, display, light, signage, and any needed booth items
- Food Vendors needing electricity will be charged a service fee of \$50 and need to provide what their specific power needs will be the day of the festival (heating, cooling, etc). The GAI is not responsible for power outages.
- All Vendors agree to use only compostable serviceware including plates, cups, to-go containers and utensils. No single-use plastics or styrofoam are allowed.
- No beverages, including water, soda or alcohol may be sold by food vendors.
- Cost: \$700 for both days, all necessary forms and payment in full is due by May 3, 2024.
